Dairy Food Safety Victoria:

Who We Are

Dairy Food Safety Victoria (DFSV) is the independent Victorian statutory authority responsible for ensuring that the Victorian dairy industry is meeting national and international food safety standards. It was formed with industry agreement and input, by an Act of the Victorian Parliament – the *Dairy Act 2000*. DFSV is a government organisation, accountable for the safety of all dairy foods produced in Victoria for domestic and export markets. It reports to the Minister for Agriculture. DFSV licenses participants in the dairy industry from farm to the back door of retail across Victoria. **All enquiries about applying for a dairy industry licence should be directed to the Licensing Officer at DFSV.**

The licence issued to industry participants is a passport to operate in the Victorian dairy industry. Only properly licensed persons or organisations are permitted to produce milk for sale or be involved in its production, transport, manufacture or distribution. Substantial economic benefits flow to licence holders through DFSV services that help the industry maintain and enhance its reputation for safety and quality.

Certain businesses and vehicles operating in the dairy industry sector need to be licensed. A current and valid dairy licence must be held by:

-  a dairy farmer
-  a dairy manufacturer
-  a dairy food carrier
-  a dairy distributor
-  a milk broker

What We Do

All industry sectors receive a wide range of specific and general benefits from their licence. The first of these is the industry-wide technical infrastructure and support needed to protect the integrity and reputation of Victorian dairy products domestically and overseas. Our industry, being a major exporter of dairy foods is continuously scrutinised by our overseas customers as well as domestic consumers and health authorities. There is increasing demand from these sectors not only for a safe product but also for safe production systems that are environmentally sustainable. The “clean and green” image is important for our industry and DFSV.

To preserve and enhance this image DFSV is active, often in partnership with industry groups, or on its own, across a range of issues and practices. The key products and services provided by DFSV include:

- ✚ Verification and validation of dairy food safety systems
- ✚ Technical information
- ✚ Operations policy and standards
- ✚ Issues and emergency management

What Our Objectives Are

The objectives of DFSV as outlined in the *Dairy Act 2000* are to:

- ✚ Ensure that standards which safeguard public health are maintained in the Victorian dairy industry, and
- ✚ Ensure that it performs its functions and exercises its powers efficiently and effectively.

What Our Functions Are

The functions of DFSV as stated in the *Dairy Act 2000* are to:

- ✚ establish, maintain and improve -
 - the food safety standards of dairy food
 - the construction and hygiene standards for plant and equipment in dairy manufacturing premises
 - the maintenance, cleanliness and hygiene standards of dairy transport vehicles
- ✚ monitor and review the above standards
- ✚ approve and monitor the implementation of food safety programs
- ✚ administer the DFSV licensing systems
- ✚ ensure appropriately qualified persons are appointed as authorised officers
- ✚ fix and charge fees for carrying out of its functions and exercising its powers
- ✚ protect public health in consultation with the Department of Human Services or a Municipal Council, and
- ✚ advise the Minister on matters relating to dairy food safety administration.

Our Fees

The *Dairy Act 2000* gives DFSV the power to set fees for the issue, transfer and renewal of dairy industry licenses. The Act also requires the fees to be set in consultation with the industry. DFSV must develop the criteria and structure of the licence fees. The criteria may include the value of services provided to licensees, the value of industry wide benefits and the scale of operations for each licensee.

The current licence fees for dairy farmers, manufacturers, distributors, and carriers operating within Victoria are detailed in the tables following. A fee calculator is also located at the DFSV website, www.dairysafe.vic.gov.au, to assist in calculating the current licence fee.
